I. Harold declared the meeting open and welcomed everyone. He also explained that for the purposes of the AGM, all those present were members of Renaissance Sackville and were therefore able to vote on the various motions brought before the meeting

II. Virgil Hammock moved to approve the agenda, Chris Ward seconded the motion, motion carried

III. Janine O'Reilly moved to approve the minutes of the 2010 AGM, Kate Bredin seconded the motion, motion carried.

IV. Harold explained that the internally restricted net assets that are included in the net assets column include \$10,000 that was set aside for Sackville 250 celebrations, \$5000 set aside for increased staffing costs for Sackville 250 activities, and an additional amount budgeted but not yet paid to the Town for various services. Theresa Richards asked for clarifications on the amount owed to the Town, and Harold explained that because the Renaissance Sackville office is in the Town Hall, services like phone, internet and photocopying are paid for annually per use. Mike Tower moved to adopt the report as presented, Ron Aiken seconded the motion, motion carried.



V. The slate of Board members for 2012 was presented to the meeting. Sue Rose asked how people are nominated for the Board of Directors. Harold explained that people can volunteer at the AGM, but most members are asked directly by the current Board of Directors. Virgil Hammock asked about the maximum number of members, and Harold indicated that it is about 17. Virgil Hammock moved to accept the nominations, Bruce Phinney seconded the motion, motion carried.

VI. Chair's Remarks: Harold directed attention to the activity report at the back of the AGM booklet which highlighted some of the projects Renaissance Sackville has been a part of in 2011. He pointed out the Youth Video Camp, which was held at Faucet Media Arts Centre, and offer a dozen young people a chance to learn video skills they would not otherwise have access to; the Downtown Revitalization projects, which improves the look and 'feel' of Sackville's downtown core; and the Sackville Community Garden, which has grown to near self-sufficiency.

Rob Paterson asked how many plots the Community Garden has, and Theresa Richards responded that they have expanded this year to 49 plots, and about 30-40 members (some with more than one plot). Rob commented that the Urban Garden in Charlottetown is just getting started and could use any advice that the Sackville Community Garden could give.

Joyce O'Neil asked if businesses had to approach Renaissance Sackville to access the Downtown Revitalization funds, or if Renaissance could go to businesses and offer it. Harold responded by saying that it is a combination of both. Joyce pointed out that the windows of the store fronts in Sackville get very dirty, and it looks awful. She suggested that maybe Renaissance Sackville to look at getting the windows cleaned.

Harold summed up by saying that Renaissance is concerned with looking for things that aren't happening yet in Sackville, but have been identified by people in the community as something they'd like to try.

VII. Closing of business meeting: Mike Tower moved to adjourn the meeting

Annual Report

The past year for Renaissance Sackville has been filled with acheivements that highlight what a community can do when everyone works together on a common goal.

Renaissance was instrumental in obtaining over \$60,000 from Heritage Canada to celebrate Sackville's 250 th anniversary, and with the help of the Town of Sackville, the Sackville 250 committee made it a celebration to remember.

We used our annual grant-funding budget to invest in community projects that had a wide range of implications, touching on many people in many different walks of life over the past year, as well as supporting the 250 celebration.

And the addition of more hours for the Community Engagement Coordinator allowed for more networking and connection-making between groups, growing capacity for volunteers and assisting with adminstrative work that would otherwise slow down the progress being made.

Renaissance Sackville was created to stimulate the economy, but it has grown to add more than just economic value to the community. As a go-between for the Town and the community at large, we are able to facilitate grass-roots change and community development in a way that allows for learning to happen.

These three pillars of our mandate - networking, funding and community development - are essential to the future of the organization and the community as a whole.

As we move into our 20th year of existence, Renaissance is poised to continue this important work, in varied and everchanging ways.

How it all fits together

Building on community

Like a pebble dropped in a pool of water, the work that Renaissance Sackville does often has a ripple effect. Usually, that pebble begins with the networking process. By talking to the community, we can begin to link projects and ideas. The process leads to funding opportunities, which allow for greater community development, relieving the amount of money needed from municipal government for these smaller projects.



Networking & Community Development: Making connections within the community

It's not all about funding projects through grants. Sometimes all it takes is some administrative support. It is difficult to measure the value of time spent helping an organization - minute taking, press releases, meeting space, organization and dissemination of information – all these little jobs can make the difference between success and failure for community groups relying mainly on volunteers. Even in this technological age, time spent one-on-one, finding out the details of what an organization does is incredibly important - and it translates to increased productivity for all groups, and is often the starting point for new partnerships!



Our Vision & Mandate

Vision:

Sackville will be a vibrant, economically and environmentally responsible, aesthetically pleasing, caring, friendly and gracious community.

Mandate:

- To support and promote the Town's plans for community development of the Sackville area
- To maintain a structure for Renaissance that allows for vision development, planning and action in all areas of community development
- To support and become involved in community group's efforts which align with Renaissance Sackville's vision
- To seek funding and manage budget to implement plans
- To lobby Municipal, Provincial and Federal Government for support and/or funding for community development
- To maintain a wide range of external partnerships, which will allow us to work effectively with other community groups, avoid duplication, and expand our resources
- To encourage community spirit in all residents, inspiring involvement in planning, decisionmaking, and projects that benefit the community
- To acquire by purchase, gift, bequest or otherwise real and personal property and to sell, mortgage, lease and otherwise deal with the same; and to hold all property and income arising therefore and acquired by purchase, gift, bequest or otherwise in trust for the objects and purposes for which the company is incorporated
- To make such by-laws, rules and regulations as it may see fit concerning the management of its affairs, the choice of duties and powers of the Directors and officers, the admission and expulsion of members and generally for the administration and management of its affairs, and to alter and repeal all or any of such by-laws, rules and regulations form time to time, and also to delegate to its Board of Directors all or any of the powers of passing, altering and repealing such by-laws, rules and regulations
- To enter into any arrangements with any authorities, federal, provincial, municipal, local or otherwise that may seem conducive to the corporation's objects or any of these and to obtain from any such authority any rights, privileges and concessions which the corporation may think it desirable to obtain; and to carry out, excise and comply with any such arrangements, rights, privileges and concessions
- To do all such other things as may seem directly or indirectly to be incidental to or conducive to or convenient or proper for the attainment of the objects hereinbefore mentioned, and to be subject to all the powers as set forth in subsection 18(2) of the Companies Act




Project funding for 2012

Sometimes, all a group needs to get their ideas off the ground is a little money to get things started.

Providing seed money to promote sustainability

With every application to Renaissance Sackville for funding, the board of directors considers the sustainability of the project. Projects with plans to become self-sustaining are usually looked on more favorably, and those without plans are encouraged to develop one.

The board of directors works with community groups to make sure resources are being used to support as many people as possible - making connections between groups working on similar projects so that efforts are not duplicated.





A progressive approach to building a valuable community

It's all based on three (not-so-simple) steps. Of course, these steps don't always go in order!



All great things begin with a person with an idea. Shared with a small group, the capacity for success is small, but sharing with a network of groups allows for connections to be made and ideas to be improved. Acting as a network hub for the entire community, Renaissance Sackville is able to help share ideas and create partnerships.

Once an idea has been developed, and partnerships formed, sometimes community groups still need help getting the idea off the ground. With our modest seed funding, Renaissance is able to make the difference between getting a project started right away and letting it sit on the back burner for months.

Whether funding is granted or not, Renaissance Sackville encourages community groups to strive for sustainability. We offer administrative support to help find ways to do that, through funding, access to alternative business models, and sometimes, just an encouraging word. As sustainable programs grow and develop, so does our community, bringing more value to the town as a whole.

PLANS FOR 2013

COMMUNITY CULTURAL CENTRE

Working with a committee of individuals representing arts, culture, and non-profit groups, we are working on plans for a shared cultural centre.

COMMUNITY FOOD MENTOR PROGRAM

This spring will see a provinciallyrecognized training program offered in Sackville for free, which will build capacity in food security and sustainability.

MORE GRASS ROOTS PROJECTS

The biggest strength of Renaissance Sackville is our ability to respond quickly to new ideas, and to give community groups a safe place to try new things. Who knows what new and exciting projects will emerge as the year progresses?

Sackville 250

2012 was a big year for the Town of Sackville: for a full year, we celebrated the Town's 250th birthday. The organization of the year's events was a collaboration between Town staff and Renaissance Sackville, supported by a 250 committee of people from various Sackville organizations and members of the public.

In 2011, a call went out to the community for proposals for 250 events and activities, with associated budgets and timelines. These proposals were the basis of an application for Building Communities through Arts and Heritage funding that Renaissance Sackville sent to Canadian Heritage at the end of September, 2011. Other requirements for this funding application were a commitment from the Town of Sackville of support and funding, and a similar commitment from Renaissance. Renaissance committed \$15,000, and Town Council agreed to \$50,000, plus in-kind support. The Community Development, Programming and Tourism Department also gave a 250 focus to much of their usual business and heavily promoted the 250 year.

We were extremely pleased to receive the news from Senator Carolyn Stewart Olsen in March 2012 that we had been awarded \$61,500 in funding!

A 250 sub-committee (Colin Penley, Ron Aiken, Rebekah Cant and Janine O'Reilly) chose the projects that most closely met Canadian Heritage criteria and would have, we felt, the most impact on the community. The original proposals added up to \$179,000, and so it was quite a task to reduce the spending to match the combined funding above. Fourteen projects were chosen, with twelve of them actually carried out (see the Renaissance Financial Report for 2012 for the projects and funding levels).

In addition to these projects, many other events and activities were given a 250 flavour by the Town and other local organizations, such as the New Years Levee, the 250 Farmers Market, Tantramar Heritage Trust's Heritage Day, Fall Fair and many others. The Town of Sackville funded the incredibly successful Fireworks Display and the 250 Timeline street banners, as well as many interesting promotional items, such as the 250 postage stamps, flags, pins, and shopping bags.

Some highlights of the year were:

- The 250 Community Play: a stunning success with around 40 actors, plus musicians, conjured up by Ron Kelly Spurles.
- The 250 birthday party weekend: with Atlantic Cirque, and Eddie Chase & Graffiti 4 at the Bandstand park; the fireworks at the Ball Fields; Scotty & the Stars children's show, and the evening concert with Ray Legere, Ivan and Vivian Hicks, and Stacey Read, at the Music Barn.
- 250 Years of History and Fashion: over 20 poignant stories from Sackville's history, with associated costumes and props.
- Then and Now: an exhibition from the Heritage Review Board, with photographs of Sackville's buildings and other sites, as they once were and as they are today.
- Sackville I'm Yours: Moving Images: 3 evenings of short films about Sackville or by Sackville people, from archival material to home movies - riveting!



- Songs We Sang in 1762: a musical event representing founding members of the community a M'ikmaq singer/drummer, a Planter quartet, a Fife & Drum Corps, and Acadian music
- Sackville 250 competition: an eight month long newspaper contest sponsored by the Sackville Tribune Post and eleven local businesses and organizations

These and many other events and activities made for a very successful celebratory year. Four Capital Projects ensure that the 250 legacy lives on beyond 2012: the 250 Fountain by Peter Manchester (installation is planned for some time in 2013); the Marsh Barn sculpture in the Waterfowl Park, by John Haney; the restoration of a part of an antique barn at the Agricultural Field Day (for exhibitions and displays); and the Owens Art Gallery Evan Rensch catalogue of very beautiful and moving photographs of workers at the Enterprise Foundry.

The community really came together to make 2012 a very special year that will be remembered for a long time. Renaissance Sackville extends a huge "thank you" to the dozens of people who committed time and energy to events and activities large and small.
